Ellen is a psychiatrist/researcher who has worked for the last 35 years focusing primarily on the brain mechanisms involved in bipolar disorder and severe irritability in



children and adolescents. As Bob and Ellen transition into retirement, they plan to spend even more time on their lifelong hobbies which have included extensive travel, hiking and cooking.

At this time of year CC@H volunteers can also assist Full Members with seasonal-related tasks including moving bulky items to the curb for spring clean-up, light gardening/planting flower pots, setting up garden hoses for the spring and summer, setting up outdoor furniture or moving light indoor furniture, installing hooks for clothing or garden tools, rides to an accountant or tax preparer's office, helping with Easter/Passover shopping, and other seasonal activities.
